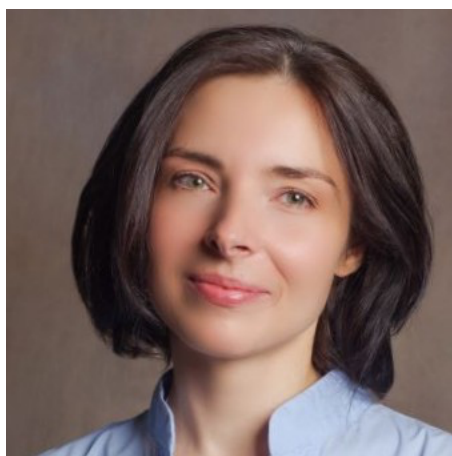

She is Jean Monnet Chair Holder in “EU Legal Studies and Legal Europeanization” and the academic coordinator of the interdisciplinary Jean Monnet Modules “EU, Security and Fundamental Rights” and “Greening the Armenian Legislation and Policy in Line with EU Acquis for Sustainable and Resilient Society (GreenPoLe)”. She heads the Doctoral School in Sustainable Development and serves as Acting Director of the newly established Italian-Armenian Institute at EIU. Lying on the cross-roads of Law and Political Science, her research interests cover a wide range of topics including the interdisciplinary issues of constitution-making, methodology of law- and policymaking, as well as reform performance assessment (with the specific focus on the Rule of Law and Justice sector reforms). She is specifically interested in the issues of European integration and Europeanization processes in third countries, EU External Relations and the role of the EU as a security and development actor in EaP countries, as well as external implications of the European Green Deal. Anna Khvorostiankina has a PhD in Theory of Law (2012, Kyiv-Mohyla Academy and Legislative Institute of the Verkhovna Rada of Ukraine), a Master of the II Level in European and Transnational Law from the University of Trento (Italy) and LLM from Kyiv-Mohyla Academy (Ukraine).
